### TERMS

1. Payment: Invoices due upon receipt. Payment via payroll service due net-15.
2. Late Fee: Overdue Invoices are subject to 10% compounded late fee per month.
3. Cancellation: "Kill Fee" of 50% due if canceled within 48 hours, 100% if within 24 hours.
4. Pre-Production: 50% of labor fee for prep days and tech scouts.
5. Meal Breaks: 30-minutes is considered "on-the-clock", 1-hour is considered "off-the-clock"
6. Travel: All travel expenses (visas, luggage, accommodations, parking, public transport, etc) are to be paid for or reimbursed in full by Production. No exceptions.
7. Rental: Rental agreement must be signed prior to call for all equipment to be used. All third-party rentals must be paid for or reimbursed in full by Production. No exceptions.
8. Insurance: Certificate of Insurance (COI) with General Liability and Rented Equipment Coverage must be issued by Production listing Keith Morrow as Additional Insured and Loss Payee.
9. L&D: Production assumes all responsibility for any lost or damaged items related to the Production during the term of the shoot. Production is responsible for paying the insurance deductible.
10. Storage: Files will be stored for a minimum of one month, longer upon request and fee.
11. Copyright: All files recorded by Keith Morrow are property & copyright of Keith Morrow until all invoices, fees, and payments in full. This includes but is not limited to labor, equipment fees, L&D, expendables, and reimbursements.
12. Acknowledgment: Delivery & receipt of this document indicates Production's acceptance of the rates & terms listed herein unless otherwise documented in writing between Production and Keith Morrow.
